New York Metropolitan Showcase was established in January 2008. The primary purpose of the organization is to assist both male and female student-athletes in the New York City in their efforts to enroll and play soccer at colleges throughout the US.

The showcase is now in its 5<sup>th</sup> year and it will be held on **Saturday November 24, 2012 at the Boys High School Field in Crown Heights, Brooklyn, New York from 11:00 a.m. to 3:00 p.m.** High schools from Brooklyn, Manhattan, Staten Island, Queens and the Bronx have been invited to participate in this event. Students must register in advance to participate; this allows us to provide the visiting coaches with a synopsis of the students' background and accomplishments.

Coaches will be invited for institutions in the New York metropolitan area (New York, New Jersey and Connecticut) and other states. We are confident that we will have a minimum of twenty-five college coaches and/or their representatives in attendance.

**To be eligible players must have completed their junior year of high school.** Each college coach will have a resume booklet that describes the academic and athletic achievements of each player. The players will wear a numbered shirt that corresponds to the same number on their registration form.

Student athletes can apply individually and will be assigned to teams based on player position. Whenever possible, athletes will not play on a showcase team with their former club or high school team mates.

The program will also include presentation by a coach and a student athlete and an information desk will be set up for questions regarding financial aid and generally college admission requirements. The games will be of a half an hour duration 7V7.
